Re: Information Regarding Your Health Benefits

Learn More About a Shift in Your Health Benefits Your Medical Plans will be Provided by the California Schools Employee Benefits Organization (CSEBO) Effective 7/1/23

Medical insurance for active employees and retirees is periodically reviewed by the District. In spring 2021, the District began looking in detail at alternatives to the Gold Coast Joint Benefit Trust for medical insurance. The goal of this review was to identify alternatives that would be better for everyone.

At the end of the review, CSEBO was selected as an alternative to Gold Coast that would provide the same or better medical insurance options. CSEBO is located in Camarillo and has a long history of helping school districts, employees, and retirees to access high-quality affordable health insurance.

What Do You Need to Do

At the July 1, 2023 transition, all VUSD health and welfare eligible Active Employees will stay on their existing medical plan. Your same Kaiser and Anthem Blue Cross plans will remain in place, with a few improvements, as well as dental and vision coverage.

There will be an available self-pay upgrade to the current vision plan for all employees currently enrolled in vision coverage. If you are not currently enrolled in vision coverage you will be eligible to add vision coverage and the optional, self-pay upgrade during 2023 open enrollment. This option is available for eligible employees starting on July 1, 2023.

Also, starting on July 1, 2023 there will be a cash in lieu of benefits option for eligible employees. More information will be mailed to all employees on both of these options closer to the July 1, 2023 transition. The next open enrollment for District Self Pay employees will be October, 2023 with an effective date of January 1, 2024.
