Parents/families and school staff were provided multiple opportunities to provide input. The Expanded Learning Opportunities (ELO) Grant was agendized over multiple school board meetings. Feedback was elicited and information was shared through Parent Advisory Committee (PAC) meetings. School staff provided input through existing LCAP Advisory Committee Meetings. School site administrators were consulted through standing meetings and requests for written feedback. During plan implementation parents/families and school/district staff will be surveyed and involved to help refine the professional learning/development options selected.

A description of how students will be identified and the needs of students will be assessed.

Secondary campuses conducted focus groups and/or surveys of students representative of high needs populations. VUSD collects diagnostic data of elementary students that, in addition to standards-based report cards, will be utilized to identify students with atypical learning gaps. Secondary students with multiple failing grades and/or students who are off track for graduation will be identified for additional supports. Students with excessive absences, multiple referrals and/or behavioral needs may also be identified.

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

Parents/families of identified students will receive informed notification of opportunities for supplemental instruction and support through a variety of communication efforts. Communication may be provided in writing, phone call, email, ParentSquare, etc. from either school site staff and/or from district staff. Parents/families may receive individual notification and/or may be invited to school site and/or district meetings to learn about supplemental instruction and support options for their student(s).

A description of the LEA's plan to provide supplemental instruction and support.

VUSD will invest in comprehensive professional learning and development opportunities for parents/families and classified/certificated staff designed to identify and support students with distinct academic, behavioral, and/or socioemotional needs. The district will expand upon current efforts to implement UDL (Universal Design for Learning), Multi-Tiered System of Supports (MTSS), culturally proficient and inclusive pedagogical practices, and data teams designed to benefit all students, with an emphasis on improved outcomes for English learners, low income students, foster and homeless youth, students with disabilities, and other underserved populations. Additional instructional time will be made available through a variety of in-person and asynchronous learning opportunities. Additional learning opportunities, such as tutoring and/or small groups, may take place before, during, or after school hours, on weekends, and/or during summer. Behavior teams will be trained and utilized districtwide, with an emphasis on early elementary. Socioemotional supports through districtwide curriculum, access to counselors and/or social workers will focus on those students and families demonstrating the highest need for additional services. Additional personnel to assist with evidence-based data practices will be utilized and additional digital programs will be acquired to facilitate efficient and effective access to data for decision-making. Expanded access to WiFi will be prioritized for secondary campuses. Additional literacy and mathematics supports will be implemented at the elementary schools to identify and remediate initial and ongoing gaps in reading and mathematics. Additional sections and site/district personnel will either be acquired or retained, based on the full impact of declining enrollment, in order to maximize flexibility across secondary schools to meet the unique circumstances of high needs students. Additional synchronous and asynchronous credit recovery opportunities will also be made available. Training and additional personnel will be made available to support Student Study Teams (SSTs) and the elevated student needs that may be identified via individualized support plans.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

In an effort to extend the supplemental instruction and support strategies implemented through Expanded Learning Opportunities Grant (ELOG), the district will utilize multiple funding sources over multiple years. This sustainability strategy will include use of other federal Elementary and Secondary School Emergency Relief (ESSER) funds to extend availabilities of supplemental services beyond the August 31, 2022 termination of ELOG funding. Strategic utilization of state and federal funds will be aligned with the district's Local Control and Accountability Plan (LCAP), which is a three-year plan requiring approval of the VUSD Board of Education.

The Expanded Learning Opportunities Grant (ELOG) was adopted by the Board of Education on May 25, 2021.

Expanded Learning Opportunities Grant Plan Instructions: Introduction

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code* (*EC*) Section 43521(b). Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- "Supplemental instruction" means the instructional programs provided in addition to and complementary to the LEAs regular
 instructional programs, including services provided in accordance with an individualized education program (IEP).
- "Support" means interventions provided as a supplement to those regularly provided by the LEA, including services provided in
 accordance with an IEP, that are designed to meet students' needs for behavioral, social, emotional, and other integrated
 student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- "Students at risk of abuse, neglect, or exploitation" means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (EC Section 43522[h]).

The seven supplemental instruction and support strategies are:

- 1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
- 2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
- 3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
- 4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
- 5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
- 6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
- 7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.
- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in
 distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional
 services are offered.
