# 16.a Career Technical Education (CTE) and CTE Grant Update

Chief Innovation Office Dr. Rene Rickard gave an update on Career Technical Education (CTE). Dr. Rickard noted that CTE courses in VUSD provide students with hands-on learning, help students make informed decisions about their path after graduation, prepare students for skill-based careers, and are UC a-g approved. Dr. Rickard discussed CTE pathways offered at our schools and highlighted the new agricultural pathway at Sa'aliyas Ranch. Dr. Rickard noted that Sa'aliyas Ranch had a community event this past Saturday and there were approximately 450-500 people who attended. Dr. Rickard shared information on Vision-to-Marketplace (VTMP) where VUSD students work with local businesses to sell student-created and produced products. Lastly, Dr. Rickard discussed funding received through various grants and programs.

### 16.b Board Appointed Committees and Board Meetings Dates/Structure for 2023

Board President Sabrena Rodriguez led a discussion regarding perspective meeting dates, the structure of the board meetings, and Board-appointed committees for 2023. Ms. Rodriguez discussed the possibility of having one Board meeting per month for business items and then a second meeting if needed to be dedicated as a study session. The Board reviewed a list of current committees and discussed if they should continue with all of these for next year. Lastly, they discussed organizational leadership in preparation for the organizational meeting in December. This item will be brought back for further discussion at the November 8, 2022 board meeting.

## **CONFERENCE - EDUCATIONAL SERVICES**

### 17.a 2022 Student Academic Performance Update

Dr. Greg Bayless, Assistant Superintendent of Educational Services, presented data on recent academic performance metrics. For Elementary students, Dr. Bayless reviewed RFEP rates (Reclassified Fluent English Proficient) and CAASPP (California Assessment of Student Performance and Progress) data. For Secondary students, he focused on RFEP rates, UC/CSU A-G rates, CTE completion rates, high school AP rates, D/F rates, and CAASPP data. Data was compared to the county "all student" averages for the end of elementary (5th), middle (8th), and high school (11/12th). In summary, the data revealed strong RFEP rates; student group achievement gaps persist; an emphasis on supporting ELs in elementary; an emphasis on improving academic supports for SWD; and an emphasis on reducing student group disproportionalities.
