REGULAR SESSION - Ron Halt Classroom - 7:00 p.m.

At 7:04 p.m., Board President Matt Almaraz called the meeting to order and led the pledge of allegiance. A Moment of Silence was held in honor of Ms. Jose Montano. Mr. Montano worked for VUSD for 47 years. He began his employment as a resource teacher, became the District's Bilingual Specialist, served as the coordinator of Federal and Specially Funded Projects, and was Principal at several of our sites. He officially retired in 2007, but

continued to serve as an Administrative Substitute for VUSD through 2022. Mr. Montano served VUSD with pride and led with a focus on personal relationships.

Superintendent's Report

Superintendent Dr. Roger Rice, thanked the Board for their support in appointing Ms. Claudia Caudill as the new principal of Balboa Middle School and shared that he looks forward to her tenure.

Dr. Rice recognized Black History Month and shared the importance of honoring all of the contributions of African American citizens in our community, state and country. He gave a shout out to the newly formed African American Parent Committee and shared that he has thoroughly enjoyed attending a few of their meetings

Dr. Rice gave a huge shout out to all VUSD School Counselors in honor of National School Counseling Week.

Dr. Rice congratulated newly appointed Assistant Superintendent of Human Resources, Ms. Gina Wolowicz and noted that her family will be joining us at our next board meeting for introductions.

Dr. Rice mentioned that VUSD was just informed that they are a recipient of a one million dollar A-G Completion Incentive Grant.

Dr. Rice gave a brief update regarding new COVID developments. He shared that the Governor is considering lifting the mask mandates for individuals who are vaccinated around February 15th. We do not know at this time how it will affect our VUSD employees as this information would come from Cal -OSHA. Also, the Governor has proposed a new round of COVID related leave, which could be up to 80 hours. It is proposed that it would be retroactive to January 1, 2022 and possibly run though the end of September 2022.

Dr. Rice introduced Ms. Elliana Tenenbaum, a former El Camino High School student who graduated this past December, one month after her 15th birthday, with her high school diploma and completing her first two years of undergraduate course work. Ms. Tenenbaum currently attends Arizona State University and is pursuing her Bachelor of Science degree in Nursing. Ms. Tenenbaum took a few minutes to address the board and thanked El Camino staff for helping her to get where she is. Principal Guerrero and Board Members took turns congratulating Ms. Tenenbaum.

Dr. Rice took the opportunity to recognize the VUSD Gratitude Award recipients for the month of January. The Gratitude Awards were designed to recognize exceptional VUSD teachers, employees, volunteers, students, and administrators associated with VUSD. There were a total of 87 submissions who will receive a certificate of acknowledgement. Five individuals were randomly selected to also receive a \$50.00 Amazon gift card.

Student Board Members Karyme Fierros, representing Foothill High School, Sierra Sanchez Rosales, representing Pacific High School, and Sophia Green, representing El Camino High School, gave brief updates on the exciting things happening at their school sites.

15.a Student Board Members

16.a Universal Transitional Kindergarten (TK)

Ms. Gina Wolowicz, Assistant Superintendent of Human Resources, gave an update on Universal Transitional Kindergarten (TK). Ms. Wolowicz shared that TK is the first year of a two-year kindergarten program that uses a modified age and developmentally appropriate curriculum taught by a credentialed teacher. A timeline of proposed changes to the program over the next four years was reviewed, which included the birthday eligibility requirement for each school year moving forward as well as the classroom ratio of adults to students.
