The Board decided to allow the Declining Enrollment ad hoc committee members, Trustee Velma Lomax and Trustee Matt Almaraz, proceed with narrowing down the application selection process alongside Dr. Chandler and Dr. Rice, before bringing this back to a future Board meeting for final Board approval before moving further.
